NEGOTIATIONS UPDATE – LARRY COBBLER

OSTA has nothing new to report on negotiations. We are just waiting to see what the district is going to do with the January payroll. Once we see that the district is not paying according to our interpretation of the agreement, a grievance and unfair labor practice will be filed.

It is time to start putting together our openers for next year's bargaining. Article I, Agreement, Item 4 of our contract says: "That there will be an annual re-opener on salary and up to two additional articles elected by each party." Article IV, Negotiation Procedure, Item 1 of our contract says: "No later than the first Board meeting in February of each calendar year, both parties will have submitted their initial proposal for public input. No later than March 1 of each calendar year, both parties shall meet and negotiate in good faith..."

CTA POSITIONS ON UPCOMING PRIMARY ELECTIONS – BY LARRY COBBLER

With the Feb. 5 California Primary quickly approaching, CTA has announced its positions. On presidential candidates, CTA has not taken a position for any one individual at this time. For propositions, see below:

Proposition 91: CTA recommends a NO vote. This is a transportation initiative that was actually addressed in 2006 with the passage of Prop. 1A. It was a mistake that it ended up on the ballot, and even the sponsors of the initiative are NOT supporting it.

Proposition 92: CTA recommends a NO vote. CTA supports community colleges and the important role they play in educating Californians, but Proposition 92 (Community Colleges, Funding, Fee Limitation) will cause more problems than it claims to solve.

Proposition 93: CTA recommends a YES vote. Proposition 93, the *Term Limits and Legislative Reform Act*, reduces the number of years a legislator can serve from 14 to 12 and allows all of those years to be served in either the State Senate or State Assembly. Proposition 93 addresses the need for greater experience and effectiveness in the State Legislature. It strikes a reasonable balance between the need for new people and fresh ideas and the need for experienced legislators with the knowledge and expertise to deal with the complex problems facing California.

Propositions 94, 95, 96, and 97: CTA recommends a NO vote on all of the Indian Casino Gaming propositions.

UPDATING OSTA BYLAWS – BY LARRY COBBLER

CTA is requiring all locals to update their by-laws this year. This is a daunting task and too much for any one individual to handle. Rodger Townsend, our policy chair, is heading up a committee of executive board members to take on this task. With the help of Michael Carantenuto, our CCHS site representative, we have a side by side comparison of our by-laws and the recommended format from CTA. After the committee gets the by-laws updated and into the proper format, they will come to the general membership for a vote. After they have been approved, they go to CTA for approval or corrections. If corrections are needed, the committee will see they are completed and returned to the general membership for approval. Then again, back to CTA for their approval.
